### Background

The Clean Communities council's Environmental Ambassador program began in may 2009 when Quamir Payton, 9-year-old resident of East Orange and student at Gordon Parks Academy, accepted the title. Payton is credited with spearheading the statewide Slam Dunk the Junk campaign in April 2007 when he addressed a crowd of public officials and reminded everyone to Slam dunk the Junk, use trash cans and recycling bins, and keep litter off the ground. In June 2010, Payton accepted an award winning check from Ringling Barnum in the amount of \$1,000 and gave it back to the City of East Orange to maintain the city's eco-garden. The Environmental Ambassador for 2010-2011 is Miranda Pawline, a resident of Delanco, who spearheaded a recycling drive in the local school, municipal buildings and surrounds to keep plastic bags out the Delaware River where she lives.
